Talofa lava,

Thank you all for your work in the important efforts of disaster preparedness, response, and planning.

I recently had the solemn experience of setting foot in the area of Maui and historic Lahaina that was utterly destroyed by the sudden wildfire, and had a congressional briefing on site from FEMA. They are examining all the ways that immense tragedy got to that point, and it's a terrible reminder of how important disaster readiness can be.

You have your role in that, and the federal government has a share in supporting your work here. Like you, I'm concerned with reports of a possible government shutdown. I know without doubt, that the vast majority of my colleagues don't want that outcome; most of them strongly support adding funds to current disaster responses - in Maui, flooding in California, hurricanes in Florida, and more.

My fervent hope and expectation is that any such shutdown is still avoidable, or will be very short, and I hold out hope there will be a successful Continuing Resolution or a breakthrough in negotiations. History says it will be resolved, and we will move

All of us know that our islands are not immune from major natural disasters.

The terrible 2009 tsunami came with so little warning. Cyclone Gita caused great damage. Every year there are hurricanes in the

In our own volcanic island chain, we've had rumblings, and elsewhere in the Pacific others have experienced worse. I was recently in Papua, New Guinea, where our dedicated military from our Indo-Pacific Command was assisting with the response to a volcano there in Bougainville, where the ash-fall had interrupted drinking water sources and food supply for thousands. We can never anticipate all the possibilities, but it's so important to plan and prepare for urgent action.

I am confident that FEMA will be fully funded for the next fiscal year, as it was for the current year, and I look forward to passing along any reports from Congress.

Thank you to Governor Lemanu Peleti Sialega Mauga, Lieutenant Governor Talauega Eleasalo Va'alele Ale, for your leadership, and especially the Office of Disaster Assistance and Petroleum Management, and Director Lisa Tuato'o, for your outstanding work, and putting together this Summit.

# ROBERT J. FENTON, JR. 😻 FEMA



#### **REGIONAL ADMINISTRATOR**

**REGION IX-**



Robert J. Fenton, Jr. is the Regional Administrator for FEMA Region 9. Prior to 2015, he served as the Deputy Associate Administrator in the Office of Response and Recovery at FEMA Headquarters and was responsible for coordinating the Federal response in support of States during major disasters. He coordinated and integrated Federal interagency allhazards disaster planning and response operations; managed emergency response teams; and oversaw disaster emergency communications programs.

Mr. Fenton came to FEMA Headquarters in July 2009 to serve as the Acting Deputy Assistant Administrator for Response, where he was instrumental in crafting the reorganization of the Response Directorate and the Office of Response and Recovery, as well as leading the Response Directorate's focused efforts on whole community catastrophic planning, doctrine development, staff training/credentialing, and exercises. Mr. Fenton previously worked at FEMA Headquarters as the Acting Deputy Operations Branch Chief in 2007, leading the development and implementation of the Incident Management Assistance Teams.

From 2006 to 2009, Mr. Fenton served in the dual roles of Director of Disaster Assistance and Acting Director of Disaster Operations in the FEMA Region 9 Office. Mr. Fenton was responsible for the delivery and coordination of all hazards disaster planning, and response and recovery activities in the Region, which serves Arizona, California, Nevada, and Hawaii, as well as Guam, American Samoa, the Mariana Islands, Marshall Islands, and Micronesia. As the Minister for Natural Resources and Environment and Minister for Tourism, his aspirations are for the transformation of Samoa into a green economy that focuses on sustainable energy and low carbon emissions, building climate resilience in all sectors, rebranding into culturally sensitive sustainable tourism, conserving and sustainably managing limited natural resources, and conserving native biodiversity for present and future generations. 

Lipea's efforts increased the resiliency of local communities to be prepared before disasters strike. As the Red Cross liaison in the AS EOC, he contributed Red Cross perspective for ASG COVID-19 EOC service decision making. During COVID and the border lockdown in American Samoa, Lipea was the Red Cross rep who helped with a Red Cross chartered special flight for stranded Alaskans and a FEMA IMAT's rotation. He also assisted Red Cross support for stranded USA citizens in Apia Samoa from Australia and New Zealand due to USA border close down requested by Apia US Embassy.
